



## October 2023 Release Highlight: Code-less extension of master data interfaces


You can now use ASAPIO Payload Designer (built-in) to extend master data interfaces, e.g. for custom fields, code-less.

## October 2023 Release Highlight: Rework failed documents in SAP Fieldglass

New feature:

# You can now rework documents in SAP Fieldglass, which failed to be posted successfully in the SAP backend systems, instead of logging on to the SAP ERP system.

E. g. for situations where documents are locked/edited in the backend, wrong cost object selected or other process/booking errors. Supported for the following documents (can be switched on/off per document):

- ✓ Time Sheets
- ✓ Expense Sheets
- ✓ SOW Characteristics
- ✓ Service Receipts
- ✓ Invoices



## October 2023 Release Highlight: PR/PO integration before work order acceptance

New feature:

### Support to update PR/PO of a resubmitted/reworked work order, after supplier's rejection.

- ✓ This is an alternative option to the recommended standard integration flow, where work order creates the PR/PO after supplier's acceptance
- ✓ The feature helps to avoid customization efforts, e. g. at brownfield customers with established processes
- ✓ Can be switched on with new global parameter FG\_PO\_BEFORE\_ACCEPTANCE
- ✓ Supported for PR/PO integration flows + Direct PO integration flows



## October 2023 Release Highlight: PO upload to SAP Fieldglass

New feature:

### Introducing a new PO upload interface for MM-SRV customers.

- ✓ A fully collaborated and approved Purchase Order from an SAP ERP system can be uploaded to SAP Fieldglass, creating the SoW
- ✓ The PO can originate in SAP S/4HANA or SAP ECC, including replicated POs from SAP Ariba Buying
- ✓ Various triggers to send the PO are configurable (i.e., statuses Released, Changed, Confirmed)


